**PHILIPPINES**

**Government protests probe of drug war deaths**

MANILA – The Philippine government hit back Saturday at United Nations rights experts seeking an international investigation into the unlawful killings during President Rodrigo Duterte's drug war, calling the push "an outrageous interference" on the country's sovereignty.

Presidential spokesman Salvador Panelo accused the UN special rapporteurs of "peddling a biased and absolutely false recital of facts" and said the Southeast Asian country was an independent democracy with a working judiciary.

Panelo argued that Duterte's war on drugs, which the government says has killed more than 5,000 people suspected of being addicts and dealers during the past three years, was based on the "primary duty of the state" to protect its citizens. Police operate on strict protocols, he said.

Rights groups have placed the number of deaths at 20,000 to 30,000.

On Friday, the special rapporteurs called for an investigation into the killings, noting that there had been a "staggering number" of unsolved and unlawful deaths, along with official attacks on rights defenders in the country. They said the inquiry should begin before the Human Rights Council convenes a new session this month.

**ENGLAND**

**Elizabeth marks birthday; duchess thrills crowds**

LONDON – Queen Elizabeth II celebrated her 93rd birthday with a parade Saturday, a cause for Meghan, the duchess of Sussex and wife of Prince Harry, to make her first official engagement since the birth last month of their son, Archie.

The queen's birthday falls on April 21, but she traditionally plans birthday festivities for June because of typically warmer weather then. The crowds were in luck: After a rainy morning, the sun popped out.

The queen arrived at the Horse Guards Parade near Buckingham Palace by carriage, where some 1,400 soldiers took part in the spectacle.

The queen's husband, Prince Philip, who turns 98 on Monday, did not attend; he has rarely been seen in public since entering retirement.

The crowds were especially thrilled to see Meghan, who did not participate in the official events that took place for President Donald Trump's three-day state visit to Britain last

week. The former actress is considered a sharp critic of Trump's policies.

**SYRIA**

**Soccer player, icon of rebellion dies after battle**

BEIRUT – A Syrian soccer goalkeeper who became an icon of the rebellion against President Bashar Assad has died of wounds suffered in a battle with government forces, rebels said Saturday.

Abdelbaset Sarout, 27, rose to fame as a player for his home city of Homs and won international titles representing his country. When peaceful protests broke out against Assad in 2011, Sarout led rallies and became known as the "singer of the revolution" for his songs and ballads.

After the arc of the Syrian uprising, Sarout later took up arms as the country slid into civil war. He led a unit of fighters against government forces and survived the government siege of Homs. The government declared Sarout a traitor, banning him from soccer and offering a reward for information leading to his arrest.

He remained an icon among Syria's opposition as the rebellion came to be dominated by hard-line Islamist groups. Many activists and rebels came to refer to him as the "guardian of freedom," a play on the Arabic word for goalkeeper.

**SPAIN**

**Permit finally given to church after 137 years**

BARCELONA – Property owners have a new yardstick by way of Spain for measuring frustration over building permit requests they suspect get lost in a local government bureaucracy.

Barcelona's City Hall finally has issued a work permit for the unfinished church designed by architect Antoni Gaudi 137 years after construction started on La Sagrada Familia Basilica.

The city said Friday that it granted the current builders a license that is valid through 2026. The builders think that will be enough time to finish raising the landmark Catholic church's central towers.

The basilica's first stone was laid in 1882, but Barcelona officials said there was no record showing that a building permit first requested in 1885 ever was granted or rejected.

Barcelona officials said the city will be paid \$5.2 million in fees under an agreement negotiated with a foundation devoted to completing and preserving La Sagrada Familia.
