

CONTRACT ASSIGNMENT AND ASSUMPTION AGREEMENT

This Contract Assignment and Assumption Agreement is made by and between the **Houston-Galveston Area Council of Governments (H-GAC)**, **John Deere Shared Services, Inc. (Contractor)** and **Honnen Equipment Company (Assignee)**.


